Subject: Provisional affiliation of the school - Grant thereof.

Dear Sir,

With reference to your application dated 30.7.1979, I am to convey sanction for composite affiliation (classes I to X) of your school w.e.f. 1.1.1980 to 30.4.1983 with permission to start classes IX to XII from June, 1980.

Names of the languages to be introduced in classes IX and X be intimated so as to enable this office to issue necessary sanction for the same.

The sanction is subject to the fulfilment of the following conditions and conditions as may be laid down by the Board from time to time.

1. That necessary furniture ~~should be~~ provided in the school and the laboratories and library ~~are~~ equipped as per requirements of the Board by 31.5.1980.
2. That Reserve Fund of Rs. 10,000/- is deposited in the bank in the joint names of the Chairman of the Board and management of the school.
3. That the fees and other charges shall not be raised without prior permission of the Board.
4. That the school premises shall be used for educational purposes only.
5. That the school shall observe Inter School Rules strictly.
6. That it will help the Board in the smooth conduct of the examinations by placing the necessary accommodation i.e. Halls/Rooms available in the school premises and furniture at its disposal for holding its examination free of charges, if required to do so.
7. That admission to school shall be open to all without discrimination of caste and creed and the school shall not impart education which is against the national interest.
8. That it will spare sufficient teachers for invigilation purposes at the examinations of the Board. Atleast one teacher may be spared for every 12 candidates appearing from the school.
9. That a fresh staff-statement for Secondary Classes may pl. be sent for verification every year.
